**Staff Duties, Responsibilities and Experience** – List all supervising individuals and key personnel taking part in performing work on this project. Describe the work to be performed by the individuals named and detail their specific qualifications and substantive experience directly related to implementing HGM or similar analyses on other projects. Project staff identified in this proposal may not be substituted or changed without prior written approval from AIDEA and the NPS.

**Subcontractors** – List and identify any subcontractors used to perform any work associated with this proposal. Subcontractors or teaming partners identified in this proposal may not be substituted or changed without prior written approval from AIDEA or the NPS. Describe the work to be performed by the individuals named and detail their specific qualifications and substantive experience directly related to implementing HGM or similar analyses on other projects.

A response prepared specifically for this proposal is required. Marketing resumes often include non-relevant information which may detract from the evaluation of proposal. Lists of projects are not useful. Focus on individual's specific duties and responsibilities and how project experience is relevant to the proposed contract.

- 6. Q: Do the polygons include HGM already? asked at the pre-proposal conference not sure exactly what the question was, please correct
  - A: Yes, the wetland delineation completed in 2014 included HGM analysis.
- 7. Q: Will the LIDAR & GIS be available?
  - A: Yes, LIDAR & GIS will be available for the successful offeror after award.


