Answer: Tatitlek dump is permitted with ADEC.

Question: What is the value of the 10-gallon tank?

Answer: The existing tank is valued at \$35,000.00. In the event of loss, the contractor shall be responsible for replacing the tank as built.

Question: Is the owner furnished materials in Anchorage?

Answer: Tank appurtenances provided with the tank is listed in Section 33 52 13. Contractor may visit the AEA shop to verify. Contact the AEA Project Manager Bill Price 907-771-3000 for access.

Question: Point of Sale?

Answer: The fuel dispenser and card reader equipment. The dispenser is defined in the specifications. The card reader and point of sale system shall be Fuel Master System or approved equal, see specifications for details. Complete system will require final approval through submittal process. The Contractor shall provide complete system, installation by certified technical as specified.

Question: Does Tatitlek have equipment to rent?
