QUESTIONS AND ANSWERS

Question #1: Regarding to the SEC 1.13, Can be provide it a valid conference line number?

Question #2: Can be Schedule another Pre-proposal conference?

Answer #2: A non-mandatory pre-proposal conference scheduled for January 26, 2022 at 10:00 am

Question #3: The RFP asks for a lot of information and costs in such a short timeframe, Could you please allow a 1-week extension?

Answer #3: Unfortunately, there is not extension; As today, the deadline for applications for Round 14 of the Renewable Energy Fund (REF), AEA has received 39 applications. It is not anticipated that all 39 applications will be subject to an economist reviews as solicited in this RFP.

Question #4: Will the winning proposer be locked into the cost given for the example grant application? I didn't read anything in the proposal indicating that and I don't see how it could since applications will vary in complexity. So my main question is... what would prevent a proposer from low-balling the cost proposal? Instead of requiring a cost for an example project, maybe a fairer and less cumbersome method to compete on cost would be to require the hourly labor rate for several key project roles. We see that frequently on term contracts. Several recent AIDEA RFPs did it that way?

Answer #4: Per application, costs will vary depending on the complexity of the application under evaluation. Unit costs should be accurately represented in an offeror's application. As per Section 3.06 of the RFP, "Cost proposals must include fixed hourly rates for all employees and sub-contractors that includes all direct and Indirect costs associated with the performance of the contract, including, but not limited to, direct expenses, payroll, supplies, overhead assigned to each person working on the project, percentage of each person's time devoted to the project, and profit. Proposed billable hourly rates become a part of the contract(s) awarded resulting from this solicitation."Awardee(s) of this solicitation will enter into a Standard Agreement for Professional Services with AEA. As part of this standard agreement, a template of which is provided in the posted RFP on page 35, will include a "Not to Exceed" clause which will limit the reimbursement amount available to the awardee(s) for services provided. While AEA cannot control for misrepresentation of costs as submitted by an offeror, it should be noted that such a "not to exceed" clause should deter such action taken by an offeror, as the provision of services by the offeror would be limited in its reimbursement to the amount agreed to and stated in the "not to exceed" amount.
