TO ALL PLANHOLDERS:

All RFP recipients on record registered as Plan Holders for RFP# 23039

The RFP Package is hereby clarified or changed as follows:

1. Question: Are responses required to be submitted on the submittal forms exactly as they are presented in the RFP? (i.e., no custom layout/branding?) – see Section 4 Proposal Format and Content.

ANSWER: No. Responses to open questions can be presented in whatever format the proposer chooses, presuming the page count requirement is met.

2. On page 17 of the RFP (Sec. 4.02), it notes that Submittal Forms B-E have a max page limit of 2 pages per form. However, the forms themselves (pages 51-58 in the RFP) each note a maximum of 5 pages per form. Which is correct?

ANSWER: Page limits are 2 pages per form, each side of the page is considered 1 page.

3. The experience section does not request letters of reference, but these are mentioned in the evaluation criteria. Do the evaluation add that requirement?

ANSWER: Letters of reference will not count against the total page count. Note that the reference letters are only one of multiple factors included in the evaluation criteria.



4. Our experience with a similar project to inspect facilities in hundreds of villages was that direct travel expenses were reimbursed separately from the "Total Hourly Field Rate." Please confirm that this hourly rate should be for labor and equipment for the field inspection team and that the direct travel costs (airfare, lodging, state per diem) will be reimbursed separately under the Time and Materials invoice format.

ANSWER: Yes.

Electronic Record and Signature Disclosure

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Alaska Industrial Development & Export Authority (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent
